Direct Cremation

Our charges for a direct cremation without an attendant, rites or ceremonies includes removal of remains (25 miles) this includes one removal person, basic services of staff (9am – 3pm M-F), necessary authorizations, 1 person to perform identification, 96 hours of refrigeration, filing of death certificate, submitting a death notice to the local newspaper, and crematory fee. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are: cardboard.

Basic Services of Funeral Director and Staff

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for services; arrangements conference with family or responsible party (9 am – 3 pm M-F); preparation and filing of necessary authorization and permits; recording vital statistics; staff assistance prior to, during and following, coordination with those providing other portions of the cremation. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance, utilities expenses, secretarial and administrative cost, and equipment.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains).

Embalming

N/A

If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
